SUBJECT: Center for Comparative Medicine Per Diem Charges

The Center for Comparative Medicine (CCM) exists to provide high-quality, cost-effective husbandry, administrative, and technical support for animal care and use, and to ensure the well-being of animals involved in research and teaching at the University of Virginia.

Our Center's services include the daily care of animals—feeding, watering, bedding changes, cage sanitation, enrichment, health monitoring, veterinary, pathology, and technical services—as well as oversight of facility maintenance and administration. While we've made numerous operational improvements to enhance efficiency and maintain excellent standards, animal care per diems at UVA have not increased in over a decade.

As many of you are already aware from numerous prior communications and discussions over the past two years, CCM and the Office of the Vice President for Research (OVPR) have been preparing the research community for a future per diem adjustment. During this time, we intentionally subsidized the per diem model to give researchers adequate time to plan, while also working hard to stabilize costs by partnering with vendors for feed, bedding, and essential supplies—helping to moderate the impact of global price fluctuations and supply chain challenges affecting research institutions nationwide.

Effective July 1, 2025, and as approved by the CCM Faculty & Staff Advisory Committee (CFAC), OVPR, and UVA Finance, all animal care per diem and special services rates have been increased by 3.0%. This adjustment reflects rising costs associated with staffing, consumables, and facility operations, and is necessary to ensure continued excellence in centralized animal care. These new rates are now in effect and will be reflected in your July 2025 invoice.

It remains our mission to support the high-quality care of animals, and the research needs of investigators at UVA. Providing centralized care to all animals at UVA allows us to deliver economical, efficient, and specialized services that promote scientific advancement while maintaining the highest animal welfare standards.



CCM strives for full cost recovery, while remaining competitively priced compared to peer institutions and upholding exceptional standards of care.

We understand that the current funding climate remains challenging, and we are committed to working collaboratively to support you.
